

## LOCAL HISTORY AND HERITAGE - THE IVALL HOMESTEAD CIRCA 1830

Built around 1830, the house is of square logged construction. The particularity of the building is that it faces south, and not towards the road, in order to maximize sunlight. The south side contains two beautiful multi paned-windows. It also has three slate roof dormer windows.

Alexander Ivall and Jane Kerr were the owners of the property between 1850 and 1917. In the late 60s, it belonged to Mr. Robert Edmund Feilde. It was restored by the Mayer-Lauzon family in 2015.

An interesting story related to this house is that in the 1870s, Alexander Ivall left his home with his oldest son to go work on the Carillon Canal. His wife Jane Kerr stayed on with the nine other children. When autumn arrived, he sent his son home with the horses and never came back. Everyone thought he had died or been killed. Many years later, one of his grandsons, who was a conductor for the Canadian Pacific Railway, discovered that an old man by the name of Sandy Ivall was living in Sutton, Quebec. He went to investigate but did not find his trace. Only in 1967 was it discovered that this man was in fact Alexander Ivall who had disappeared in 1870 leaving behind his wife and children for a girl named Bell, 18 years his junior, whom he married. She gave birth to a daughter, Susan. He died March 14, 1911 at the age of 79. Jane Ivall Kerr remained in Mille-Isles until her death, March 18, 1917.


### NATIONAL MENTAL HEALTH WEEK

# MAYOR'S ADDRESS

Mrs. Sarah Channel, General Director and Treasury Secretary, left us on March 16<sup>th</sup>, 2019 after having been a major factor in the building an atmosphere of trust within the municipality. Her professionalism and being approachable and caring have allowed Council to achieve its objective that made it enjoyable for you to not only communicate with your elected officials but also allow you to receive professional services from employees in a congenial atmosphere. She was for me, during three years, a genuine partner who could provide wise council for the purpose of our collective well-being.

The Council and I welcome with enthusiasm Mr. Pierre-Luc Nadeau who will commence his duties as General Director and Secretary Treasurer of our Municipality. He was appointed March 25, 2019. He possesses the qualities required to pursue the work undertaken by Council with the same concern for transparency.

I wish to thank Mrs. Andrée-Ann Larocque, Director of Urban Planning and Environment, who not only fulfilled the task of interim General Director for the Municipality for two weeks between March 16<sup>th</sup> and March 24<sup>th</sup>, 2019. Her crucial support also deserves our thanks and recognition for the two weeks of February 24 and March 3 during which the General Director/Treasury Secretary was away on planned vacation and her Assistant General Director Marie Poupier was on sick leave.

Renewal continues in the administration. The Director of Public Works employment was terminated by Council after having worked four months for the Municipality. He is currently looking for a replacement that corresponds to pre-established criteria.

Some might think that the Municipality has a weak personnel retention rate. Let me reassure you that among the nine municipalities of the MRC during the past five years, Mille-Isles has an enviable retention rate.

Concerning the 2019 projects announced in the February 2019 edition of Info Mille-Isles , each of them has progressed. A public consultation meeting modifying the zoning bylaw in order to allow hobby farms, production, regulation surrounding short term rentals, etc., was held on April 3, 2019 following the adoption of a preliminary draft bylaw adopted by Council in March. After this public consultation, if citizens do not submit a request for participation in a referendum, the bylaw will be adopted at a session in May for submission to the MRC in order for it to pronounce itself on its conformity so it can be applicable as soon as possible.

Relating to the vocation and the restoration of the Maple Grove building as well as the will to preserve the municipality's heritage and history, Mrs. Dawn Charles is currently working with the citizens that produced the exhibition during our 150<sup>th</sup> anniversary in order to recover their excellent work that will be made public for everyone to enjoy.

The project aiming to create an intergenerational end of life care facility to help the Municipality develop into an oasis of tranquility in a lush setting, mobilizes some of its energies.

A person in charge of the "Groupe de ressources techniques des Laurentides" (G.R.T.L.) has met with us to expose the different steps to follow in order to reach the objective of creating a new intergenerational project on twenty acres of land allowing seniors needing care or even non-autonomous seniors to stay rooted and near their loved ones. Also, a promoter has been approached to cede the required land following an agreement with the Municipality, in order to approach the MRC for the project to conform to the revised land use and development plan of the MRC and be realised in our municipality. Your support for this project crucial. Your involvement and participation will be crucial to its success.

It is always a pleasure for me and your council to not only propose projects but also to invest energy and effort to realize them and they obtain the support of the majority of you.

## OH THOSE SPRING PROJECTS!

Spring and its warmer weather usually motivates residents to begin their renovation and maintenance projects. Remember to visit the urban planning section of the municipal website to check for by-law regulations regarding your projects. Residents are also encouraged to contact Mr. David Roy, municipal inspector, at (450) 438-2958 extension 2607 for guidance with renovation or construction projects.

At all times, it is essential that you dispose of your project's waste properly. To help, consult the list of materials accepted or refused at our **EcoCentre, Les bons Voisins**. For example, wood, gypsum and asphalt shingles are accepted materials at the EcoCentre in small quantities.

If materials are not accepted, or the quantities are too large, a container will be required during the renovation or construction period. Also, remember that many of these materials can be recycled which is a great help to the environment, it reduces the tonnage sent to the land fill and is beneficial to the taxpayer!

## PRIVATE ROAD CULVERTS

Here is a little reminder for private road owners who's roads cross a waterway.

You must know that standards are in place to calibrate the culverts and avoid narrowing the stream.

## GLASS : RECYCLING VS REFUND

The Municipality of Mille-Isles, through recycling, recuperates glass including wine bottles. All these are sent to the Tricentris sorting center located in Lachute. Currently, 76.76% of glass is collected and recycled. Their objective is to reach 100%.



Why is it critical to favor recycling over refunds? Refunds encourage a parallel transportation mode while the recycling truck currently drives by your entrance and will continue to do so. Selective collection is like public transit for glass, refundable bottles solo cars. 87% of all wine bottles are currently recycled through selective collection. Furthermore, Tricentris transforms glass to create new products such as insulation, cement additives, filtration sand, etc. Glass transformation plants have been built in Quebec.

Tricentris has just signed an agreement with Quebec based RV2 Technologies, totalling 100 million dollars over 20 years. This will allow them to create finished products using 30 000 tons of glass powder that will be delivered to them annually.

## ORNITHOLOGY IN ARGENTEUIL

Greetings to you all,

Développement ornithologique Argenteuil DOA is asking for support from the public, its friends and municipalities in order to collect information concerning the presence of **Chimney Swifts** on the entire territory of the MRC d'Argenteuil for the year 2019.

This small black bird the size of a sparrow that usually nests in masonry chimneys is considered "threatened" in Canada according to the ESA (Endangered Species Act). The presence of a **Chimney Swift** is absolutely not dangerous for the chimney nor its use; the nest is glued against the wall of the chimney's interior and its surface size is approximately 5 cm x 10 cm.

Your observations from years past as well as current (2019) are welcome. **Chimney Swifts** are presently wintering in the South but will be back towards the end of May. Their presence is very beneficial because their food is composed 100% of flying insects; the majority of which being biting and harmful.

The DOA study will last from April to September 2019.

A report will be published in the fall of 2019 including all your observations and available on the DOA website.

## HIGH SPEED INTERNET

### **The project**

The deployment of high speed internet in the MRC d'Argenteuil consists in the construction of a network of **fiber optic** cables more than 300 kilometers in length, mostly in the northern section of the MRC, allowing to connect potentially 4000 residences. This structuring project is taking shape thanks to funding from government programs such as Québec branché (provincial), Brancher pour innover (federal) and a contribution from the MRC.

### **Key stages**

2019: Detailed engineering and permit applications

2020: Network construction

2021: Initial operation



### **Governance**

All work related to engineering and construction of the fiber optic network are under the responsibility of the MRC d'Argenteuil. The MRC has entrusted the administration of this network including its operations (customer service) to Fibre Argenteuil Inc., a legally constituted non-profit organization. The Board of Directors was formed a few weeks ago and includes two elected officials: Mrs. Danielle Parent, councillor from Mille-Isles and Mr. Michel Filion, Mayor of Grenville-sur-la-Rouge.

## TAX PAYMENT 2019

Mille-Isles residents can pay their taxes at the municipal office with postdated cheques, Interac, or credit card. Note that Visa, MasterCard and Discover cards are accepted. You can also pay over the phone using a credit card.
