



COVID-19 AND YOUR MUNICIPALITY

On March 18 : Following the latest government recommendations, the Municipality of Mille-Isles is implementing measures to limit the spread of Covid-19 virus among the population and to protect its employees. As a result, Town Hall will remain open, with restricted access for emergency situations only.

Services to the population will be maintained. However, many employees will assume these services by teleworking. In order to limit contagion, electronic communications are therefore favoured. No appointments will be made in person until further notice.

The Strong Community Hall is also closing its doors to the general public and all activities are suspended, with the exception of council meetings, which may be held behind closed doors if required. These are exceptional measures and will be temporary.

The Municipality wishes to offer its residents the best possible service under the circumstances. You will find below relevant information to this effect:

PAYMENT OF MUNICIPAL TAXES

The taxpayers of Mille-Isles are invited to give preference to the payment of municipal taxes according to the following methods of payment:

- By telephone or electronic banking service;
- By post-dated check sent by mail;
- By telephone with a credit card.

It is always possible to plan your three payments. You must fill out the credit card authorization form found on the Municipality's website and send it by mail to Chrystine Slight, administrative technician at 1262 Mille-Isles Road, Mille-Isles, Quebec J0R 1A0, by email at cslight@mille-isles.ca or by fax at 450 438-6157.

In order to accommodate citizens and thus prioritize electronic and telephone payments, the municipal administration has decided to extend the deadline for the first payment from March 20, 2020 to May 15, 2020. Consequently, no penalty will be applied to your tax bill until May 15, 2020.

First payment: May 15, 2020

Second payment: June 19, 2020

Third payment: September 18, 2020

MUNICIPAL BY-ELECTION 2020

The electoral officer, Mr. Pierre-Luc Nadeau, announced the results of the census of votes for the position of Councillor seat 3, for the March 1, 2020 election of the Municipality of Mille-Isles.

The candidates, mentioned below, received the number of votes registered against their respective names:

- Yvon Arnold : **52 votes**
- Diane Bélair : **66 votes**
- Valérie Bouchard-Boyer : **58 votes**



Consequently, the electoral officer declared that **Mrs. Diane Bélair** obtained a majority of 8 votes.

There were 1,336 electors on the voters list, of whom **179** voted, for a turnout rate of **13.40 %** compared with 25 % in the 2017 general election.

Mrs. Diane Bélair was proclaimed elected and sworn on Friday, March 6, 2020.
