PUBLIC WORKS

On May 6th, we welcomed our new Public Works Director **Mr. Yves Latour**. A team is taking shape, in the interest of all.

Following steps taken many weeks ago, on May 7th, the ministère des Transports du Québec (MTQ) has sent three employees from the services center in Saint-Jérôme to evaluate chemin de Mille-Isles and propose temporary corrective measures in order to ensure its safety for users. We appreciate the respect of the fulfilment of the commitments made by **Mr. Claude Thibault**, regional director of the MTQ and understand the delays caused by the flooding.

During the summer of 2019, the municipality will be digging ditches and fixing roads. Fill material consisting of a mixture of earth and stone will be made available to our residents. If you are interested, you must ask for a permit from the **Urban planning and Environment department by calling 450 438-2958**. A ten-wheel truck will deliver the material to your property at no cost.

REGULATIONS CONCERNING OPEN PIT FIRES

Bylaw number 2014-08 concerning open pit fires stipulates that it is the responsibility of the person who wants to start a fire to obtain information from the "Société de protection des forêts contre le feu" (SOPFEU) regarding the forest fire danger level

before proceeding. The responsibility to supervise, control and extinguish the fire rests upon the person having ignited it, including the owner of the property. You can consult the municipal By-Law by visiting the Municipality's website. To know the flammability index for our region issued by the SOPFEU, visit our website or download the application from their website *sopfeu.qc.ca*.



Low intensity fire with limited propagation

Surface fire propagating moderately; more or less controllable

Surface fire of moderate or vigorous intensity; challenging to control

Very high High intensity fire with partial or complete flames in treetops with conditions beyond the capacity of ground control

High intensity fire in treetops, propagating at great speed; can become uncontrollable

IMPORTANT REMINDER CONCERNING MATERIALS REFUSED AT THE ECOCENTER

The objects appearing in the list below have unfortunately been found recently in the containers of the "Les bons voisins" Ecocenter. Most of these materials must be disposed of in a landfill and therefore should have been collected at your door. Large items are picked up once a month during the first pickup of the month. The dates for large items pickup are circled in red on your Garbage and Recycling calendar.

• plastics (buc ets, wheelbarrows, and plastic toys are not recyclable) • garden hoses • mattresses • office chairs

- couches paddleboat/rowboat fiberglass clothes logs (tree trunks) tree stumps tarp/cover of any type pool doorframe
- exterior siding (vinyl) solvents/paint remover) insolation (urethane/mineral wool wood contaminated by other products (ex: wood with aggregates, urethane, siding, etc.)

Monetary considerations...

When the recycler receives these materials from the Ecocenter's containers, he must send them to the landfill, at the Ecocenter's expense. But each municipality being an owner of the Ecocenter already offers the service of collecting garbage and large items. Therefore, when you throw away refused materials into the containers of the Ecocenter, you as a citizen will end up paying twice for the same service.
