TO INTERESTED PEOPLE HAVING THE RIGHT TO SIGN A REQUEST TO PARTICIPATE IN A REFERENDUM

SECOND DRAFT RESOLUTION RELATING TO THE PROJECT TO DEVELOP A BEEKEEPING WORKSHOP ON THE PROPERTY LOCATED AT 1015 TAMARACOUTA ROAD PURSUANT TO THE BY-LAW CONCERNING SPECIFIC CONSTRUCTION, ALTERATION OR OCCUPANCY PROPOSALS FOR AN IMMOVABLE (SCAOPI) NO. RU.10.2017.

PUBLIC NOTICE is given hereby :

1. Purpose of the project

Following the public consultation meeting held on May 4, 2022, the council of the Municipality of Mille-Isles adopted, on May 4, 2022, the second draft resolution relating to the project to develop a beekeeping workshop on the property located at 1015 Tamaracouta road pursuant to the by-law concerning specific construction, alteration or occupancy proposals for an immovable (SCAOPI) no. Ru.10.2017.

2. Request to participate in a referendum

This second draft by-law contains certain provisions for which interested persons may request that a by-law containing such provisions be submitted to the approval of qualified voters:

• the development of a farm building used for the additional use "farmhouse and agriculture" with an area of 230 m², for a total area of farm buildings of 310 m², despite a maximal area of 110 m²

A request concerning the subject to referendum approval may come from zone Ru-4 as well as contiguous zones Ru-5, Ru-15, Ru-16, Vi-4, Ru-14, Ru-18, Ru-6, Ru-17, Rt-1, Ru-13, as shown on this sketch.

3. Conditions for the validity of a request application

In order to be valid, a request must :

- Clearly indicate the provision it concerns and from which zone the request originates, or, in other cases, indicate the zone for which the request is being made ;
- Be received at the municipal office located at 1262, Mille-Isles Road in Mille-Isles, no later the eighth day following the one of the publication of the present notice, which is May 19, 2022 ;

Be signed by at least 12 interested persons in the zone from which it originates or by at least a majority of them if the number of interested persons in the zone does not exceed 21.

4. Conditions to be an interested person

An interested person is :

- 1) Any person who is not disqualified from voting and who meets the following conditions on May 4, 2022:
 - The person has been domiciled in the zone where a request can be made ;
 - The person had been domiciled for at least six (6) months in Quebec.
- 2) Any sole owner of an immovable or the occupant of a business establishment who is not disqualified from voting and who meets the following conditions on May 4, 2022
 - The person had been, for at least twelve (12) months, the owner of an immovable or the occupant of a business establishment located in the zone where a request can be made ;
 - Any undivided co-owner of an immovable or the co-occupant of a business establishment that is not who is not disqualified from voting and who meets the following conditions on May 4, 2022. The person has been, for at least twelve (12) months, the undivided co-owner of an immovable or the cooccupant of a business establishment located in the zone where a request can be made ;
 - The person had been designated by means of a power of attorney signed by

a majority of the persons that are undivided co-owners or co-occupants, for at least twelve (12) months, as the one who is entitled to sign the request in their name, and to have his name entered on the referendum list, if applicable. The power of attorney must have been filed or be filed with the request.

In the case of a natural person, the natural person must be of full age and a Canadian citizen, and must not be under curatorship.

In the case of a legal entity, the legal entity:

- Has designated among the members, directors or employees, by resolution, a person who, on May 4, 2022, must be of full age and a Canadian citizen, and must not be under curatorship nor disqualified from voting under the law ;
- Have filed or file with the request a resolution designating the person entitled to sign the request and to have his name entered in the referendum list, if applicable ;
- Except in the case of a person designated to represent a legal entity, in no case may the person be considered an interested person in more than one capacity in compliance with Article 531 of an Act respecting elections and referendums in municipalities.

5. No requests

Any disposition of the second draft by-law number RU.02.2011.13 for which no valid request has been made may be included in a by-law that will not have to be approved by qualified voters.

6. Consultation of the draft by-law

The second draft by-law number RU.02.2011.13 may be consulted at the municipal office located at 1262 Mille-Isles Road, Mille-Isles from Monday to Friday, from 7:45 am to 4:30 pm or on the website of the Municipality of Mille-Isles.
