

Returning Officer's Message

Dear Residents,

On November 2, you will be called upon to exercise one of the fundamental rights of our democracy: the right to vote. Voting means making your voice heard and actively contributing to shaping a municipality that reflects your values and your vision.

As General Manager and Clerk-Treasurer of your municipality, I will serve as Returning Officer. In collaboration with the Chief Electoral Officer of Québec (DGEQ), I will ensure that the election is conducted properly and in compliance with the rules set out in the Act Respecting Elections and Referendums in Municipalities.

This civic action is essential to the proper functioning and representativeness of our local institutions. I will carry out my duties independently and impartially to ensure a transparent and fair electoral process.

Requirements to Vote

To vote, two conditions must be met: you must be an elector and you must be registered on the voters' list.

1

To be an elector, you must:

- Be at least 18 years old on election day
- Be a Canadian citizen
- Not have lost your electoral rights

2

To be registered on the voters' list, you must meet one of the following two conditions:

- Be domiciled in the municipality and have lived in Québec for at least six months
- Own a property or operate a business establishment in the territory of Mille-Isles for at least 45 days

Important for Non-Residents

Any elector not domiciled in Mille-Isles, but who owns a property or operates a business establishment in the municipality, must submit a duly signed request to the Returning Officer to be registered on the voters' list (forms SMR-9.1 and SMR-9.2).

Note: During the election period, a legal entity (corporation) cannot vote.

Registration on the Voters' List

Registration on the voters' list is not automatic. Anyone who wishes to exercise their right to vote must ensure they are registered.

The Municipality's assessment rolls are not linked to the DGEQ voters' list. Payment of your property taxes does not guarantee registration on the permanent voters' list.

In the fall, a notice will be sent by mail to each address in the municipality. This document will indicate, as applicable, the names of registered persons or the lot number.	It is essential to ensure that your name and contact information are correctly listed on the notice you receive by mail.
