



**PUBLIC NOTICE**

**DRAFT BY-LAW NUMBER 2026-01 AMENDING BY-LAW NUMBER 2018-02  
RESPECTING THE REMUNERATION OF MUNICIPAL ELECTED OFFICIALS**

In accordance with the *Act respecting the remuneration of elected municipal officers* (CQLR, chapter T-11.001), public notice is hereby given by the undersigned, General Manager and Clerk-Treasurer of the Municipality of Mille-Isles:

THAT, during the regular meeting of the Municipal Council held at the Strong Community Hall located at 1262, chemin de Mille-Isles, on March 4, 2026, at 7:00 p.m., Draft By-law Number 2026-01 amending By-law Number 2018-02 respecting the remuneration of municipal elected officials will be presented for adoption.

THAT, in accordance with the Act, a notice of motion for said draft by-law was given at the regular meeting of January 14, 2026, by Councillor Stéphane Goulet.

THAT, in accordance with the Act, said draft by-law was tabled and presented at the regular meeting of January 14, 2026, by Councillor Stéphane Goulet.

THAT Draft By-law Number 2026-01, once adopted, will have the effect of amending By-law Number 2018-02 respecting the remuneration of municipal elected officials.

**SUMMARY OF THE CONTENTS OF THE BY-LAW:**

THAT the current remuneration of Council members and the remuneration proposed by said draft by-law are as follows:

Other members of Council	6 227,88 \$	9 207,64 \$

THAT the current expense allowance and the allowance proposed by said draft by-law are as follows:

Title	Current allowance	Proposed allowance
Mayor	9 341,22 \$	14 478,89 \$
Other members of Council	3 113,94 \$	4 603,82 \$

Said draft by-law also provides:

- THAT the remuneration payable to Council members will be indexed annually, as of January 1, based on the Consumer Price Index (CPI) published by the Institut de la statistique du Québec for the Montréal Census Metropolitan Area, as incurred during the preceding year;
- THAT the by-law will have retroactive effect as of January 1, 2026.
